THIS ADDENDUM to the numbered end-user license agreement (EULA) referenced above (the "License") becomes effective on the date stated above (the "Addendum Effective Date"), **on condition that you receive email confirmation** from Darden Studio of its receipt from you of this Addendum **dated and signed** by an authorized representative of Licensee.

- A. The last sentence in section 1(a) of the License is hereby deleted in connection with the uses of the Font Software permitted by this Addendum. This Addendum is effective only for a term of one year from the Addendum Effective Date. All use permitted hereunder must be discontinued by the term expiration date, subject to all of the provisions of the EULA, unless you obtain a new addendum covering a future time period.
- B. Sections 1(b) and 1(c) of the License are hereby modified to additionally permit you to express the Font Software on an Internet domain or multiple domains (which can be subdomains) that collectively are experienced by the visitor as one "website" ("domains") in live-text format using "font-face" technology only when you meet the following conditions:
 - (1) The Font Software files are protected on the domains by Cross-Origin Resource Tracking (CORS) headers to prevent unauthorized domains from making use of the Font Software.
 - (2) The domains are substantially dedicated to the licensed brand, and the brand is prominently displayed and identified on the domains (or, if there are multiple brands, they are all owned by you, and the Font Software is used only for the licensed brand).
- C. The Addendum fee is based upon the average monthly combined page-views (measured over a one-year period) on all websites that use the Font Software, up to the maximum stated above. For each domain, the page-view count is for all pages, including subdirectories and subdomains, not just the pages that contain the Font Software. The price of a new addendum will be based upon Darden Studio's pricing tables then in effect, and issuance may be conditioned upon payment of any license fee shortfall for the expired year if actual use exceeded the license maximum. (For a multi-year Addendum, you will be asked to report actual use at the close of each year, and the fee is subject to an upward adjustment if actual use in a year exceeds the license maximum.)
- D. Section 1(f) is modified to permit you to subset the Font Software files embedded in the licensed websites, on condition that you retain the Darden Studio name of the Font Software. Darden Studio is not responsible for any display or other technical problems which may occur as a result of your use of third-party software for this permitted modification.
